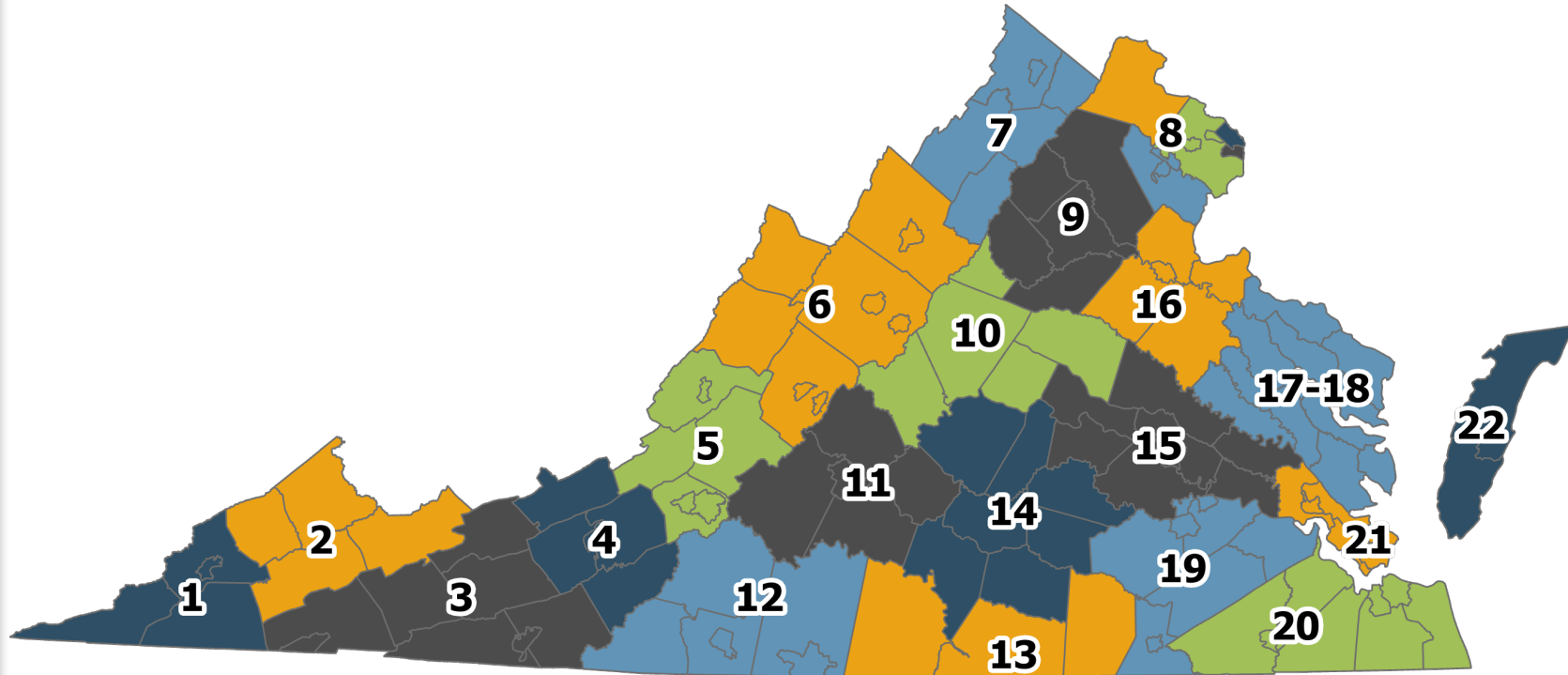

total population** in PSA 8B.<sup>1</sup>

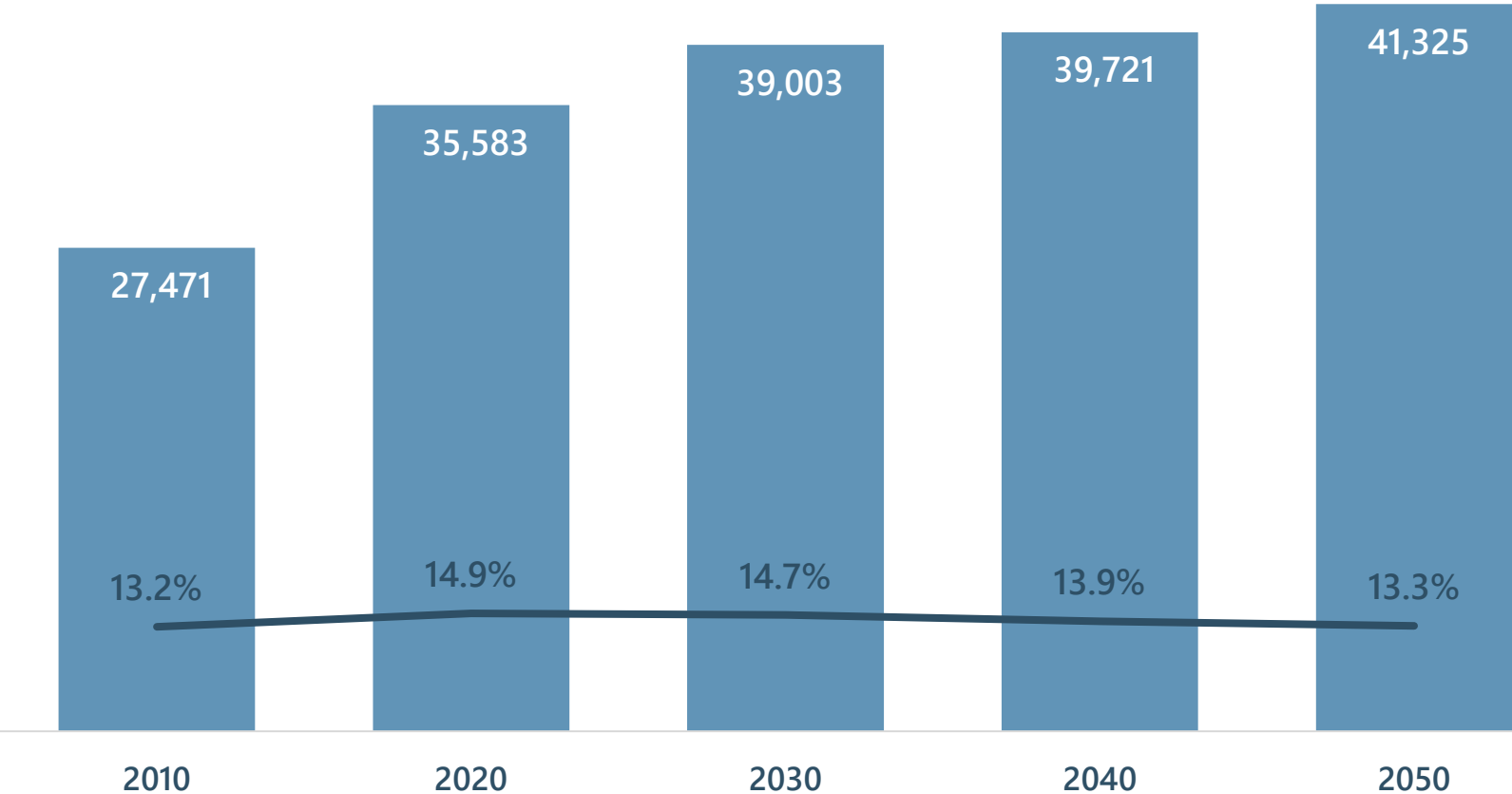


# POPULATION PROJECTIONS

By 2030, Virginians aged 60+ will comprise **14.7%** of the total population in PSA 8B.<sup>2</sup>

The 60+ population in Virginia PSA 8B is **expected to grow** but the **rate of growth is projected to decline** each successive decade until 2050.<sup>2</sup>

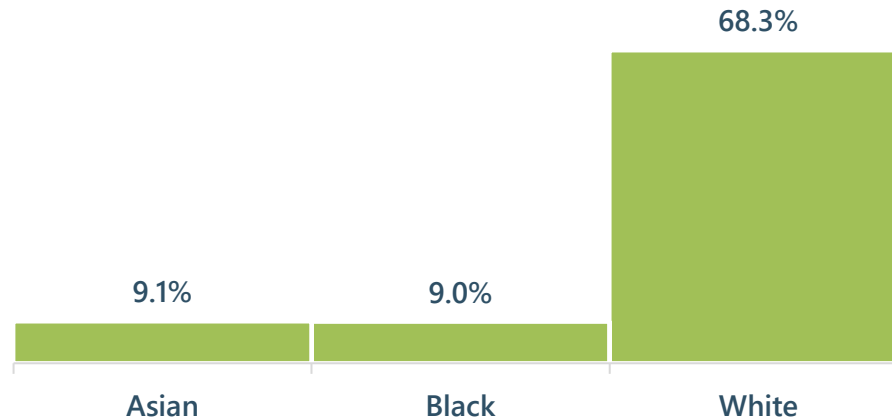

## GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



**52.6%** of 60+ Virginians in PSA 8B were **women** and **47.4% men**.<sup>1</sup>

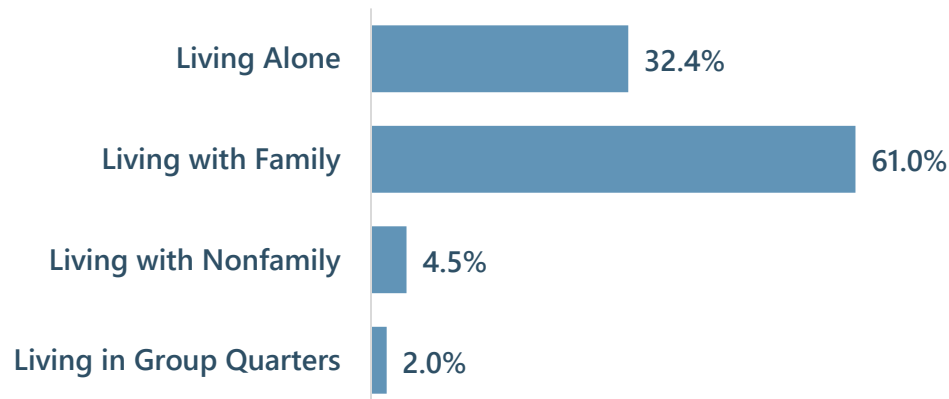
Among 60+ Virginians in PSA 8B, **12.2%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 2%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**32.4%** of 60+ Virginians in PSA 8B **lived alone**.<sup>3</sup>

**49.1%** of 60+ Virginians in PSA 8B were married or partnered, followed by **15.6%** divorced, **14.9%** widowed, **14.4%** never married/single, and **6%** separated.<sup>3</sup>

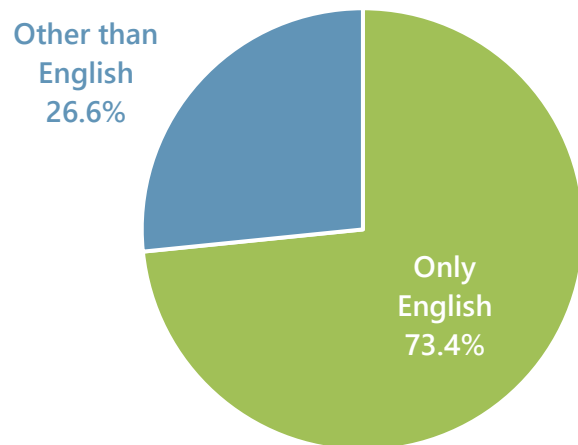

## LANGUAGE SPOKEN AT HOME



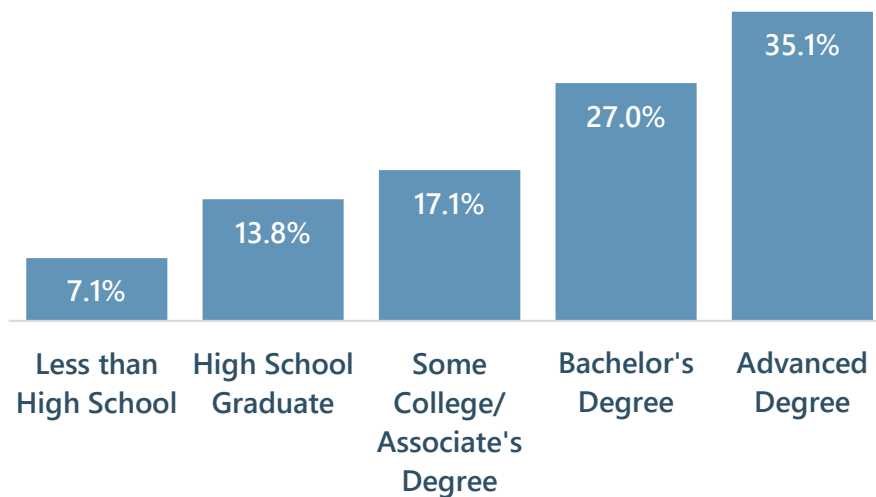
60+ Adults by Language Spoken Most at Home



**25.7%** of 60+ Virginians in PSA 8B were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 8B, **26.6%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**7.1%** of 60+ Virginians in PSA 8B had less than a high school education.<sup>3</sup>

**35.1%** of 60+ Virginians in PSA 8B had graduate or professional degrees.<sup>3</sup>

## POVERTY & ECONOMIC STATUS

**7.9%** of 60+ Virginians in PSA 8B were **in poverty**.<sup>3</sup>



**4.2%** of households in PSA 8B with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

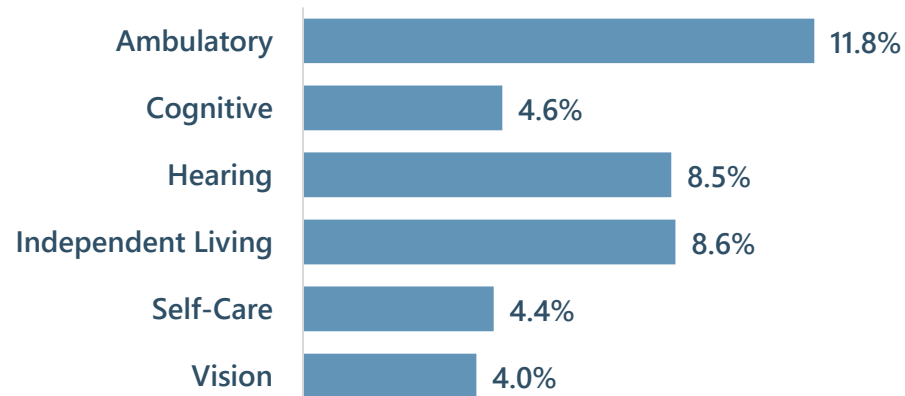


**33.2%** of 60+ householders in PSA 8B **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**21.5%** of 60+ Virginians in PSA 8B had a **disability** and **10.5%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 8B, **1.3%** had **no health insurance coverage**.<sup>3</sup>
