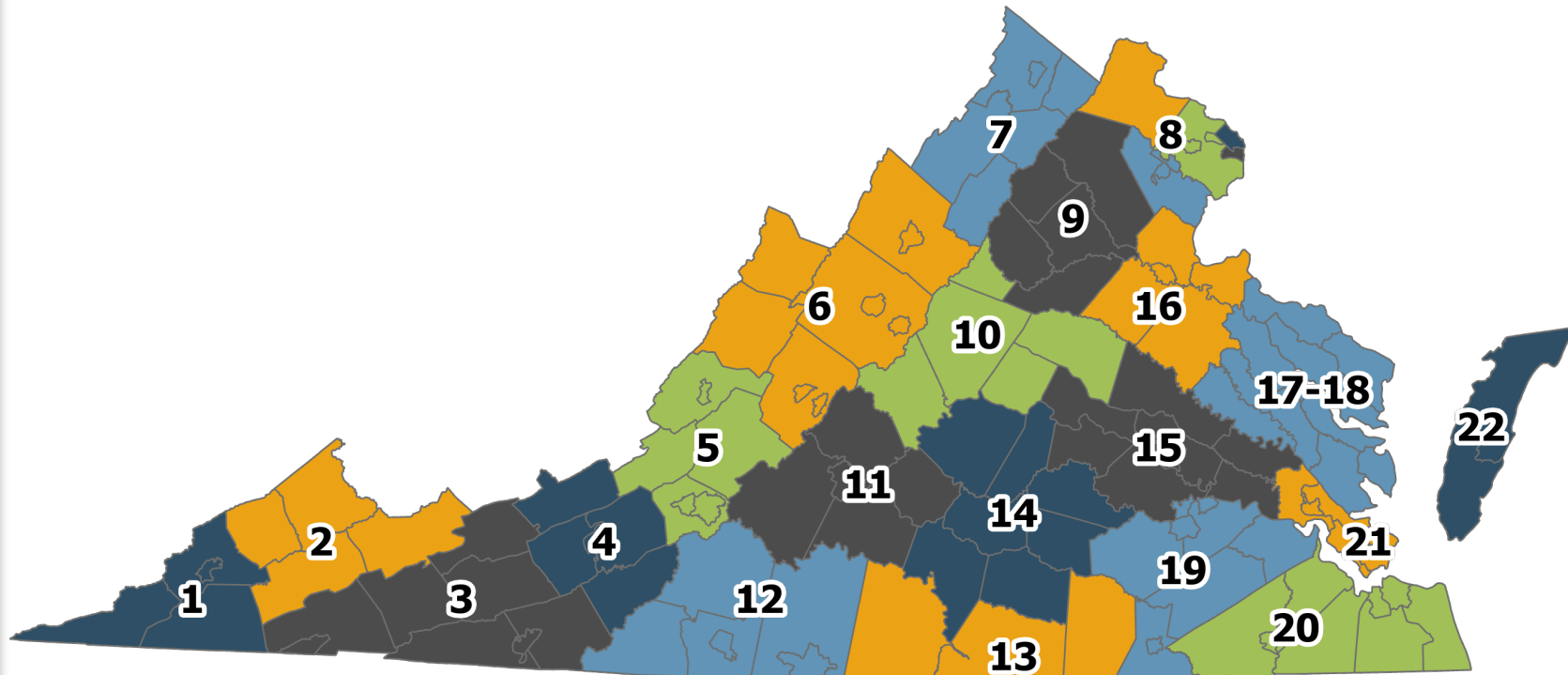

Planning and Service Area 22 (PSA) includes **Accomack County** and **Northampton County**.

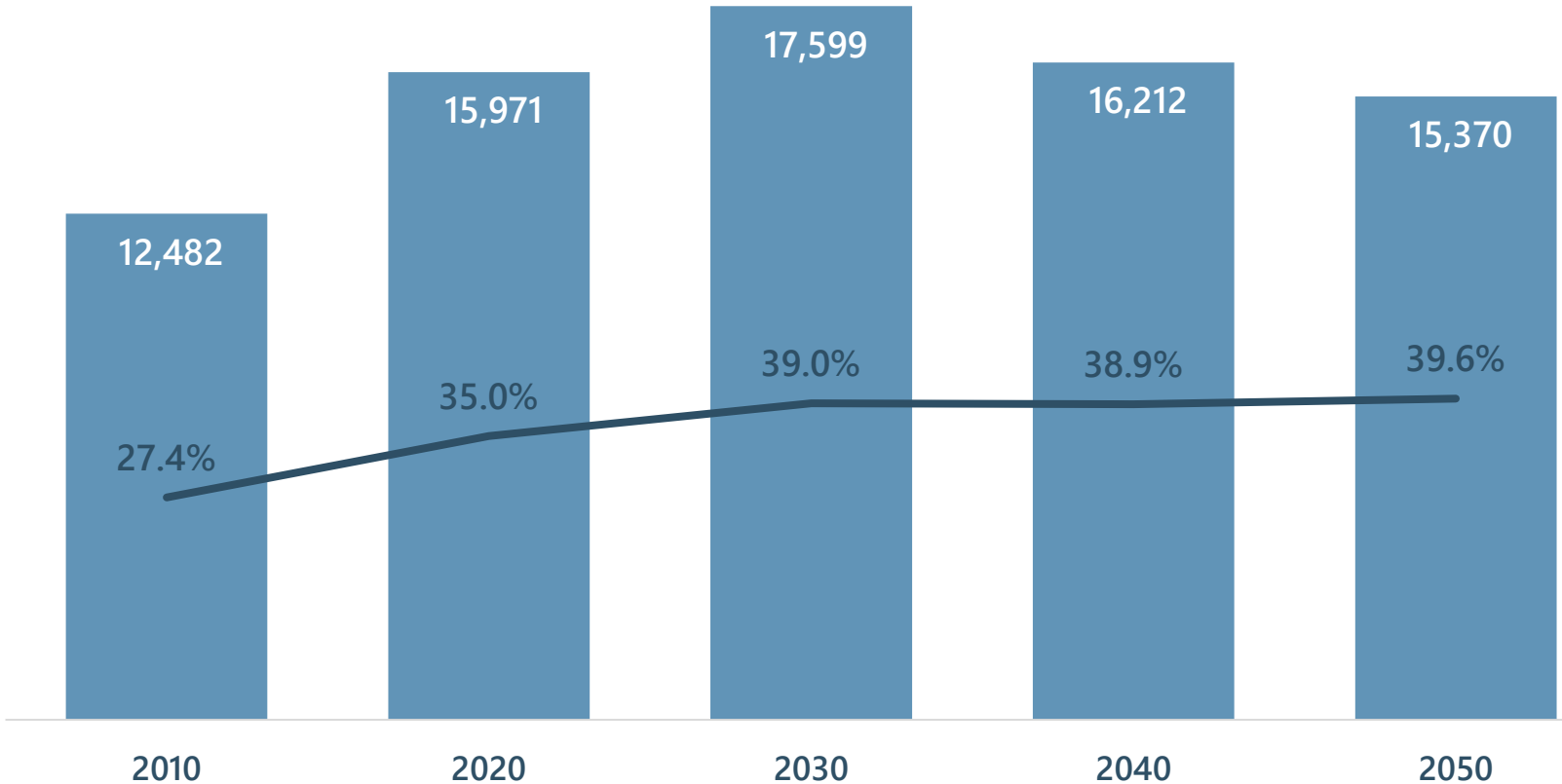
As of 2020, there were **15,637 Virginians aged 60+**, accounting for **34.3% of the total population** in PSA 22.<sup>1</sup>

By 2030, Virginians aged 60+ will comprise **26.9%** of the total population in PSA 22.<sup>2</sup>

The 60+ population in Virginia PSA 22 is **expected to decline** but the **rate of growth is projected to stabilize** each successive decade until 2050.<sup>2</sup>

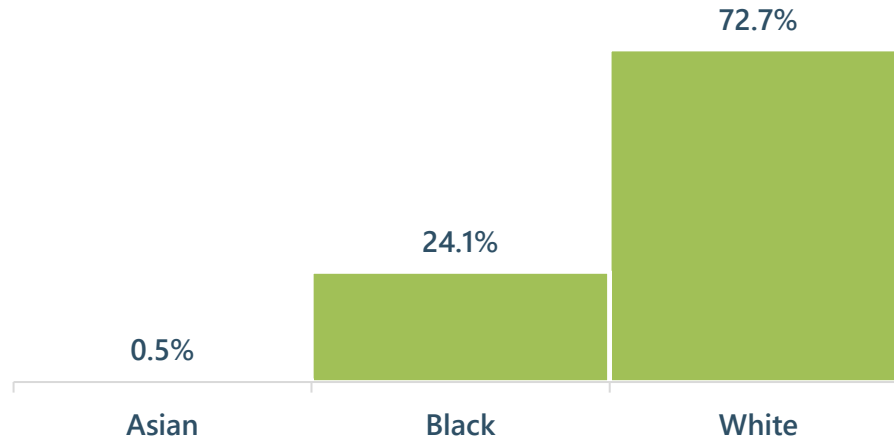

## GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



**53.9%** of 60+ Virginians in PSA 22 were **women** and **46.1% men**.<sup>1</sup>

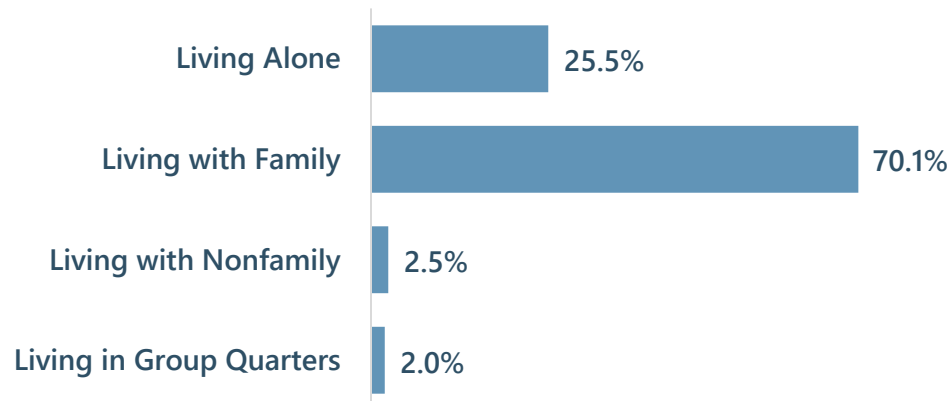
Among 60+ Virginians in PSA 22, **1.5%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 2%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**25.5%** of 60+ Virginians in PSA 22 **lived alone**.<sup>3</sup>

**59%** of 60+ Virginians in PSA 22 were married or partnered, followed by **20.8%** widowed, **10.4%** divorced, **6%** never married/single, and **3.8%** separated.<sup>3</sup>

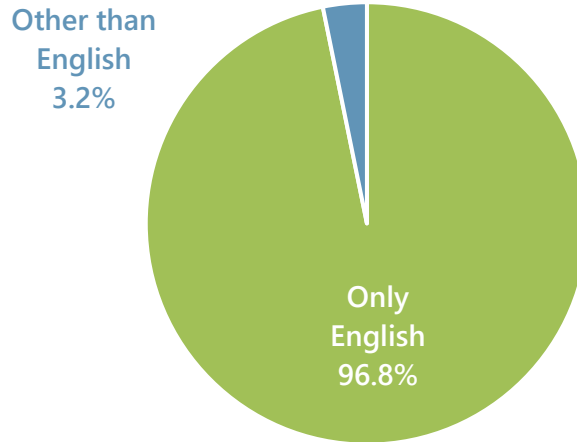

## LANGUAGE SPOKEN AT HOME



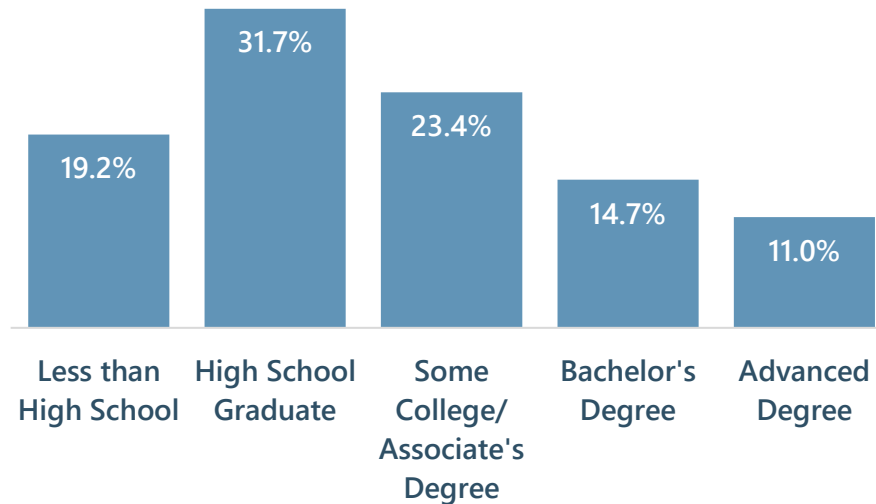
60+ Adults by Language Spoken Most at Home



**3.2%** of 60+ Virginians in PSA 22 were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 22, **3.2%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**19.2%** of 60+ Virginians in PSA 22 had less than a high school education.<sup>3</sup>

**11%** of 60+ Virginians in PSA 22 had graduate or professional degrees.<sup>3</sup>

## POVERTY & ECONOMIC STATUS

**12.8%** of 60+ Virginians in PSA 22 were **in poverty**.<sup>3</sup>



**8.3%** of households in PSA 22 with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

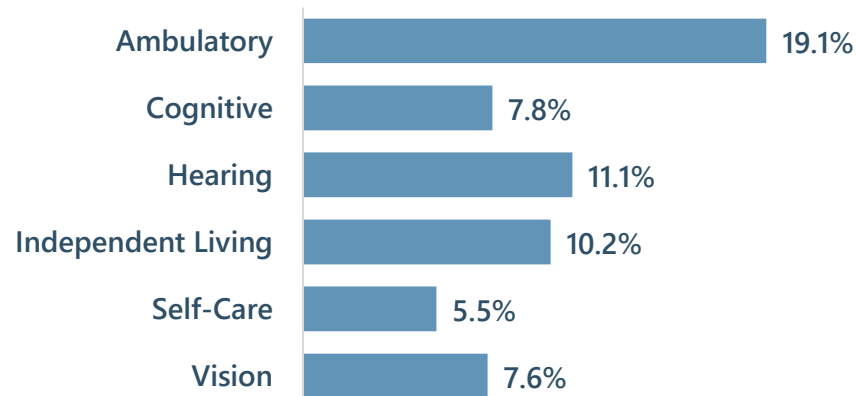


**17.8%** of 60+ householders in PSA 22 **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**31.5%** of 60+ Virginians in PSA 22 had a **disability** and **14.7%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 22, **2%** had **no health insurance coverage**.<sup>3</sup>
